

AN ORDINANCE OF THE COUNTY OF BEAUFORT, SOUTH CAROLINA, RELATING TO THE COUNTY COUNCIL OF BEAUFORT COUNTY, SO AS TO INCREASE THE SALARY THAT MAY BE PAID IN ONE FISCAL YEAR.

WHEREAS, Act No. 126, General and Permanent Laws of Statutes at Laws of South Carolina, 1975, specifies that members of County Council of Beaufort County ". . . shall receive an annual salary of Four Thousand and No/100 (\$4,000.00) Dollars and a per diem of Twenty Five and No/100 (\$25.00) Dollars per meeting attended," and "In addition thereto, the Chairman shall receive an additional One Thousand and No/100 (\$1,000.00) Dollars as a yearly supplemental salary for his additional duties."; and

WHEREAS, Chapter 9, Section 4-9-100, 1982 Supplement of the Code of Laws of South Carolina, 1976, as amended, specified that ". . . after the initial determination of salary, Council may, by Ordinance, adjust such salary but the Ordinance changing such salary shall not be effective until the date of commencement of terms of at least two members of Council elected at the next general election following the enactment of the Ordinance affecting such salary changes at which time it will become effective for all members," and "members may also be reimbursed for actual expenses incurred in the conduct of their official duties."

NOW, THEREFORE, BE IT ORDAINED by County Council of Beaufort County in meeting duly assembled, by their authority to adjust such salary by Ordinance to read as follows:

TITLE

An Ordinance in the mode prescribed by law to increase the salary and specify expenses that may be paid in a fiscal year to members of the County Council of Beaufort County.

SECTION I

A. Compensation. The members of Council shall receive an annual salary of Seven Thousand Eight Hundred and No/100 (\$7,800.00) Dollars; and

B. Special Meetings. In addition to the annual salary, members shall receive an additional salary of One Hundred and No/100 (\$100.00) Dollars for every Special Meeting of County Council attended by the member; and

C. Supplemental Salary of Chairman. In addition, the Chairman shall receive an additional Two Thousand Six Hundred and No/100 (\$2,600.00) Dollars as a fiscal annual supplement for additional duties; and


D. Mileage. The members of Council shall also receive mileage to and from their residences to the County seat at the rate prescribed by the Personnel Policies of Beaufort County; and

E. Expenses. Members may also be reimbursed for actual expenses incurred in the conduct of their official duties. (Code of Laws of South Carolina, Chapter 9, Section 4-9-100, 1982 Supplement.); and


F. Effective Date. This Ordinance shall become effective on the date of commencement of terms of members elected at the 1988 General Election.
